DriverCheck Vehicle Monitoring Program

Operating a fleet exposes an organization to a wide variety of potential losses, some of which are very difficult to control. How drivers operate their vehicles day in and day out is a major exposure that an organization can face. The fact that drivers are out operating their vehicle independently, away from your control makes it a situation that is difficult to control. Studies show that in excess of 95% of vehicle collisions occur due to driver error and these errors (poor driving behaviors) have occurred many times with the driver before they result in a collision.

How tattletale Works

Being able to see who will be involved in a loss before it happens is a luxury that employers don't have. But with driver monitoring, employers can see which drivers exhibit behaviors that are known causes of losses. With this

knowledge, pre-emptive training and corrective action can be taken before a loss occurs. With DriverCheck monitoring, companies see an average collision frequency reduction of more than 25% in the first year.
