**How It Works**

NER’s secure and confidential database includes more than 22 million ownership records and more than 100,000 theft reports. Additionally, it collects multiple points of identification for a single machine. In the case of theft, NER can use its database to apply a unique search algorithm to find possible equipment matches and enables law enforcement to identify the true owner of any registered machine.

Additionally, we also offer a theft deductible waiver endorsement\* to its insureds registered with NER. In the event that a registered piece of equipment is unable to be recovered, and the theft was reported to local law enforcement, the endorsement waives the theft deductible, up to \$10,000.
