## **Creating a Welcoming Community for International Students**

The Atlanta Ministry with International Students (AMIS) promotes cultural and global understanding through friendship and hospitality with international students and scholars in the greater Atlanta area. Through their many programs and events, they aspire to welcome those who feel like strangers, and create a more peaceful and connected world through international friendship.

The Intact Charitable Trust was grateful to support AMIS at their 43rd Welcome Reception. The annual event welcomes new and returning students from out of the country who will attend neighboring colleges and universities during the academic year. ### **Intact Scholarship Program**

Winners were selected based on criteria such as academic performance, leadership roles and participation in school and community activities. Our scholarship program is managed by Scholarship America®, a nonprofit scholarship program administrator, and is funded by the Intact Charitable Trust.
