#### Pricing

**FleetTrac330 -** \$73 per device; FleetTrac84 - \$95 per device purchased (one time cost with a one year warranty on all equipment).

**Service -** \$19 per month (per device) for industry-standard reporting every two minutes; \$21 for reporting every minute and \$23 for reporting every 30 seconds.

To reduce upfront costs, devices can be purchased through financing for an additional \$4 per month for 24 months for FleetTrac330 or an additional \$6 per month for 24 months for FleetTrac84. Service requires a two-year/24-month contact.

DriverCheck will waive all setup fees and does not charge hidden fees for additional users, maintenance, etc. with the exception of rare circumstances when customized programming is requested.
